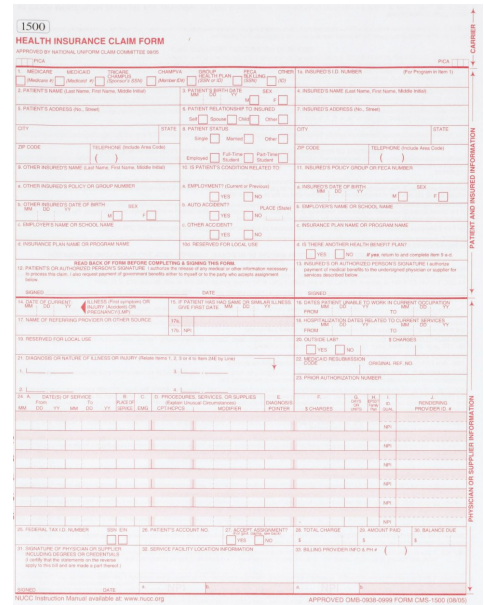
Single Location, Progress Visibility & Detailed Audit Trail

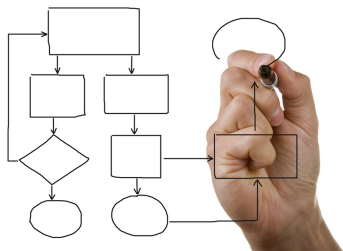
